# UWFaith Digital 🌿



UWFaith Digital officially launched in January 2024 and is open to any member or friend of United Women in Faith as a place to grow in community and access resources. The platform offers a community with like-minded sisters and a place for some of our most beloved resources such as the Program Resource, Mission u curricula, and the Daily Prayer Guide. Members can join the main space or join special-interest groups, such as Soul Care or Reading Enthusiasts.

## **Highlights:**

- UWFaith Digital grew by nearly **33%** in 2024 for a total membership of approximately **8,000** people.
- 12 Community Gatherings were held with Program Resource author Joyce del Rosario to discuss and explore the theme of food, faith, and fellowship.
- 352 Mission u leaders were trained in three curricula through this online space.

New resources available on UWFaith Digital include online learning courses (with more to come soon) and the Leadership Toolkit, which compiles resources from throughout the organization and Leadership Development Days into one convenient space.

# **Soul Care**

Soul Care events focus on nurturing your mind, body, and spirit while deepening your faith through spiritual practice and creating bonds of sisterhood.

#### Highlights:

- The Soul Care Deck was designed, produced, and launched, selling out 500 copies in three
  weeks! The Deck offers spiritually grounding practices, affirmations, and inspirational
  quotes to incorporate Soul Care into personal practice and group gatherings.
- The **Soul Care Group on UWFaith Digital** grew to over 500 members (doubled in size!) in 2024, under the leadership of Community Guide Janjay Innis.
- Soul Care launched the Registration for Soul Care Retreats, offering members support by hosting registration and offering retreat resources such as song recordings, workshops, and rituals.
- Soul Care and Digital Communities developed a **Soul Care Circles** program through the TIDEL Fellowship. Pilots will run in winter and fall 2025.


## Mission u

Mission u 2024 was centered on the theme, "The Kin-dom is Among You: Drawing Closer to God and One Another." Adults, youth, and children all explored what it meant when Jesus told his followers the kin-dom was among them (Luke 17:21).

Study Leader Training took place over two weeks in April. Training was conducted in cohorts of up to 23 study leaders and included an online course in UWFaith Digital and four live Zoom sessions led by a multiracial training team.



Some **5,609** people attended **102** conference Mission u gatherings in 2024.







In 2024, The Reading Program continued its tradition of offering books to challenge people of all ages in the areas of education for mission, leadership development, nurturing for community, social action, and spiritual growth. In 2024, Reading Program volunteer evaluators completed more than 700 evaluations, the behind-the-scenes work that makes this wonderful program possible.

By participating in the Reading Program, women can deepen their understanding of these important issues and connect with a community that shares their passion for social justice and spiritual growth.

# The Power of Our Impact

- 172,456 women, children, and youth were served by National Mission Institutions through United Women in Faith grants.
- A total of **1,432 people in Zimbabwe**, benefited through training in poultry and how to make home cleaning products. Participants also received broiler chicks, feed, and goats.
- More than 1,800 legislative actions were taken for climate justice.
- Supported **350 Earth Day** celebrations across the United States.
- **3,000 emails** to support federal bills that would help interrupt the school-to-prison pipeline.
- At the end of 2024, we had 244 active deaconesses and home missioners appointed in 44 conferences in the United States.
- Granted **192 scholarships** to students from 25 countries, totaling nearly \$570,000.

# **National Mission Institutions**

United Women in Faith assists nearly 90 National Mission Institutions across the United States. They are community centers, colleges, and residences that provide vital services to vulnerable communities. Through their work, hundreds of thousands of individuals have had access to care and education that would have been otherwise impossible. In 2024, United Women in Faith provided support to make the following successes possible:

#### Moore Community House, Biloxi, Mississippi

Financial gifts from United Women in Faith's members supported 12 cohorts of low-income women to obtain national credentials in the skilled craft trades and participate in advanced leadership courses through Moore Community House's Women in Construction program.

#### Scott's Run Settlement House, Pursglove, West Virginia

With support from United Women in Faith, Scott's Run Settlement House's food pantry provided food for more than 10,478 individuals in rural West Virginia.

#### Gum Moon Residence Hall, San Francisco, California

With the support of a United Women in Faith annual grant, Gum Moon Residence Hall was able to upgrade its website and digital presence, which resulted in securing funding from two new private foundations, for approximately \$50,000, for its family support programs.

# Camp Aldersgate Expands to Serve Adults and Young Adults

In 2024 Camp Aldersgate received \$10,000 from United Women in Faith to provide materials and supplies for their Weekend Camps, Summer Medical Camps, and Youth Volunteer program.



Camp Aldersgate launched its first-ever Adult Weekend Retreat in November 2023. Held at Mount Sequoyah in Fayetteville, Arkansas, this inaugural program welcomed 18 participants aged 19-55 and offered a range of engaging activities like lawn games, karaoke, oversized kickball, and a shared Razorbacks game viewing. This experience opened doors to further opportunities for this underserved population.

Building on the success of that inaugural retreat, we hosted our first Spring Young Adult Weekend Camp in April and our first weeklong Young Adult Summer Camp in July of 2024 for individuals aged 19-35 at Camp Aldersgate. This camp offered participants the chance to enjoy traditional activities like fishing, archery, and arts and crafts while fostering independence and confidence.

# **International Mission**

United Women in Faith is committed to empowering women and girls in Africa, Asia, and Latin America to gain competence and skills through leadership development, economic empowerment, and skills building. Our goal is to have young women make up 50 percent of the participation in these programs.

- More than 40 families received pigs from our pig distribution projects in Mozambique.
   Women will use the income from the pigs to feed their families, buy uniforms for their children/ grandchildren, and meet other basic needs.
- A total of 1,432 people in Zimbabwe, including 150 direct beneficiaries (women and girls), 950 children and youth, 150 families, and 123 passon beneficiaries, benefited through training in poultry and how to make home cleaning products. Participants also received broiler chicks, feed, and goats.



- In the **Democratic Republic of the Congo, 120 women, youth, and young adults** received various skills training, including beading, crocheting, and making household cleaning products.
- The Peruvian Country Team organized national and district trainings to empower 175 Peruvian women, with 66 being youth/young adults. The trainings found that lack of economic autonomy and violence against women were the most important issues affecting Methodist women in Peru.

To help enhance economic prospects for women, the Betty Carew Skills Training Centre, in collaboration with United Women in Faith, unveiled its newest endeavor: a catering department.



This new venture opens doors to opportunities for female empowerment and sustainable income generation.

Full of enthusiasm and optimism, Princess George, a first-year student at Betty Carew Skills Training Centre, hailed the new catering division as "a valuable asset." She believes the centre benefits not only herself and her peers but also the wider Kissy community. Initially enrolled in dressmaking, Princess can now excel in both dressmaking and professional cooking. Full of confidence, she envisions a future where she is self-employed in two fields, instead of facing unemployment in Sierra Leone.

The Betty Carew Skills Training Centre has a proven track record of nurturing and training women who are often overlooked by society. Many success stories have emerged from the centre, with individuals establishing themselves as self-employed professionals in various fields. Some women continue to serve as tutors at the centre, with some pursuing university degrees after being empowered by their training.

# Just Energy for All Climate Justice








In 2024, we continued our commitment to climate justice work through our Just Energy for All Campaign and programs including educational events and advocacy. We supported environmental justice legislation federally and at the 2024 General Conference. We granted seed funding for local leaders advancing climate solutions domestically and abroad and developed and co-branded guidelines and resources to help our members and communities to be empowered in their commitment to sustainability. We held over 18 different climate and environmental justice events, including four Just Energy for All webinars with more than 2,000 total participants in partnerships with groups like Immigration Law and Justice Network, Church World Service, Espacio Migrante, the United Methodist General Board of Global Ministries, among others.

## **Highlights:**

- United Women in Faith members and allies took more than 1,800 legislative actions in 2024 for climate justice.
- Supported 350 Earth Day celebrations across the United States including an Earth Day ceremony at First UMC Charlotte, connecting with the broader United Methodist Creation Justice Movement network and promoting climate justice and intersectionality.
- Funded **five projects** through the **Just Energy for All** seed grants in Louisiana, Colorado, Texas, Ghana, and Zimbabwe to advance green energy technologies, reforestation, and other local initiatives.
- Fostered partnerships with organizations and campaigns endorsing the faith principles for sourcing transition minerals and the Fossil Free UMC efforts, cobranded water and energy efficiency checklist with the Energy Star Program of the EPA, and participated in US Climate Action Network Groups such as the 5F Fossil Fuel Phase Out, and Breathe Again Collaborative. We also collaborated in a webinar by the Women's Environment and Development Organization on a feminist approach to a just transition, highlighting the intersectionality of climate justice, gender justice, and ethics of care promoted by faith traditions.
- Collaborated with the Immigration Law and Justice Network for a webinar on climate displacement bringing in over 1,000 registrants for that event.

# Interrupt the School-to-Prison Pipeline Racial Justice

United Women in Faith continued its work to interrupt the school-to-prison pipeline and end mass incarceration through educating and mobilizing members and friends. In 2024, many United Women in Faith conferences engaged in special projects focused on the Charter for Racial Justice or hosted special events. The Charter for Racial Justice was also a guiding principle for all five United Women in Faith Jurisdiction Gatherings.

## Office of Deaconess & Home Missioner

Deaconesses and home missioners are laypeople who are called by God to be in a lifetime relationship in The United Methodist Church for engagement with a full-time vocation in ministries of love, justice, and service.

At the end of 2024, we had 244 active deaconesses and home missioners appointed in 44 conferences in the United States.

#### **Highlights:**

- Launched our "**We're Still Here**" campaign to help bring awareness to the Order of Deaconess and Home Missioner.
- We welcomed 26 new deaconesses and home missioners and four transferring deaconesses to the Order
  of Deaconess and Home Missioner.
- We held **seven virtual discernment events** and hosted **four in-person events**, each in a different jurisdiction.



At General Conference, 26 deaconesses and home missioners were consecrated to a lifetime of service. We also passed legislation to broaden church membership requirements to support deaconesses and home missioners who work remotely, allowing them to hold membership in a church where they work or reside, and we passed legislation to remove the gendered language relating to deaconesses and home missioners from the Book of Discipline.

# **United Methodist Jurisdictions Meet**

All five U.S. jurisdictions gathered for their quadrennial Jurisdictional Conferences on July 10–13, 2024. They assigned bishops to their episcopal areas, established and populated jurisdiction-level committees, elected their representatives to general boards and agencies, determined annual conference boundaries, and promoted the "evangelistic, educational, missionary, and benevolent interests of the Church," as tasked by the denomination's *Book of Discipline*.



United Women in Faith organizes at a jurisdictional level as well and hosts its own meetings to elect its own national board of directors.

The former Central, North, and Northwest Texas conferences united to become Horizon Texas, a plan formed by the three conferences and supported by delegates to the 2024 South Central Jurisdiction Conference. The unification conference will be held Sept. 28, 2024.

This means that the United Women in Faith in these conferences will unite as well. A unification transition team comprising United Women in Faith leaders from all three conferences has been working on bringing the conferences together.

At its 2022 special session, the Southeastern Jurisdiction established a task force to study the impact of racial bias during the selection of episcopal candidates. The group brought its findings and recommendations to the body to help work for a bishop election process more free of racial bias. The Western Jurisdiction established and supported a Western Jurisdiction Committee on Native American Ministries, and the North Central Jurisdiction passed a resolution to conduct a racial audit and another to help ensure the audit can be used to move the jurisdiction to be more racially inclusive.

All conferences included monitoring and reporting by their jurisdiction's Commission on Religion and Race and Commission on the Status and Role of Women.

The Western Jurisdiction elected Kristin Stoneking and Sandra Olewine as its new bishops. These elections moved women to become 53 percent of active bishops in the United States and 33 percent of all active bishops in The United Methodist Church.

In addition to being voting delegates, several United Women in Faith members were elected to jurisdictional committees and general agency boards.


Other highlights include lay addresses by United Women in Faith leaders Lisa Maupin and Darlene Alfred, lay leaders of the Great Plains and Central Texas Conferences, and South Central Jurisdiction United Women in Faith President Ellen Lipsey's report to the jurisdiction.

In the Southeastern Jurisdiction, United Women in Faith program advisory group member Karen McElfish took time to share about the climate justice legislation that passed General Conference and encouraged them to start Creation Care programs in their annual conferences.

Every day United Women in Faith members inspire, influence, and impact their churches and communities. Those who have answered the call to leadership in The United Methodist Church have made their presence known, and our church is blessed for it.

# Leader & Officer Development

United Women in Faith leaders and officers are the life force of the organization, faithfully providing leadership at all levels of the organization, from the local unit to district, conference, jurisdiction, and national organizations.

2024 provided deeper opportunities for leaders to be equipped. More than 660 conference officers registered to attend United Women in Faith's Conference Officer Briefing where they were inspired and challenged to join in our strategic vision and direction and received the latest resources and opportunities offered through United Women in Faith.

Based on leader feedback, the Officer Resource Page (uwfaith.org/members-and-leaders/officer-toolkit) was created as a "one-stop-shop" where essential information and links are available to every United Women in Faith leader.

## **Leadership Development Days**

Held in November, with the theme "Revive and Lead: Empowered by Resurrection," Leadership Development Days 2024 included diverse workshops, networking options, soul care lounges, Spirit-filled worship, and dynamic plenaries featuring member leaders. Six Leadership Tracks created opportunities for leadership cultivation across the organization.

#### **Highlights:**

- More than 1,000 member leaders registered for LDD 2024.
- Attendees represented all 51 conferences.
- 30+ workshops, networking, and leadership track sessions were offered.
- More than **30** National Mission Institutions were represented.

# **Leadership Development Days**

Leadership Development Days 2024, November 21–23, explored the theme "Revive and Lead: Empowered by the Resurrection." This event presented an opportunity for leaders within and beyond United Women in Faith to pause, connect, and reflect on their journey as women engaged in faithful leadership.



Centered on the story of Jesus' followers' experience after the resurrection in John 20–21, Leadership Development Days asked the question: "What does it mean to lead in a post-resurrection world?"

Francine Davis, executive for education and leadership development, described this as "LDD reimagined" with a "robust leadership focus for United Women in Faith leaders at all levels. It now also includes leaders in The United Methodist Church as well as spiritual women who are exercising leadership in their local communities."

All 51 United Women in Faith conferences were represented with 1,049 people registered for Leadership Development Days 2024. Participants also joined from Brazil, Guyana, Kenya, Mozambique, Sierra

Leone, Switzerland, and Uganda. For at least 151 participants, it was their first time participating in Leadership Development Days. Forty of the people who registered identified as non-members. The ages of registrants ranged from early 20s to 90.

"You are sacred. You are worthy of taking time to pause, attend to soul care, and be in community." During opening worship on Thursday night, Elizabeth Chun Hye Lee, director of mobilization and advocacy at United Women in Faith, shared this and encouraged participants to engage LDD "in a contemplative posture."

Noting that it can be difficult to pause in the challenges of our world, Lee encouraged leaders to do so and attend to their soul care.

A portion of each of the three plenaries included guidance and time to create a personal timeline documenting events related to their circumstances and identity as a woman, their faith journey, and their relationship to justice and social issues. Participants used this timeline throughout LDD to reflect on how their stories influence their journey as women leaders.

Participant Laura Pfeffer shared, "As I placed reminders of the role of women and United Women in Faith on my timeline, I was able to reflect on these ways in which being a part of this organization has shaped and strengthened me. This is what I also want to share with other women as we invite them to be a part of our organization. It is a place of Purpose and sisterhood."

## **Distance Learning**

Distance learning allows us to provide education for leaders and members online so they are accessible to all. In 2024 we began the process of moving 150 courses from the Bridge platform to UWF Digital to increase accessibility. As part of this process, we are also reviewing and updating each course to ensure the content is relevant, aligned with our brand, and engaging for members. Some courses are being reimagined to better accommodate different learning styles and new virtual learning technology.

#### **Public Relations**

The Position team works to elevate United Women in Faith's visibility, firmly establishing the organization as a leading voice among women's Christian groups within the broader faith community and the world.

#### Highlights:

- The Project 2025 Faith Talks episode, produced in collaboration with the Samuel DeWitt Proctor Conference, placed us at the center of critical political discourse. This initiative not only attracted new members but also deepened engagement within our existing community.
- Our video assets were strategically integrated into our digital ad campaigns with SilverTech, which drove **50,000 new users** to our website in 2024.
- Following the election, we launched the Micah 6:8 Pledge to reaffirm our commitment to justice
  beyond any single election. United Women in Faith remains dedicated to racial, climate, and gender
  justice; environmental protections; women's health; immigrants' rights; and human rights, standing
  in solidarity with marginalized communities and urging ongoing advocacy.
- In 2024, United Women in Faith garnered over **11 earned news media pickups**, expanding our reach and visibility.



One of our top-performing YouTube videos, Give Bravely, encouraged viewers to act bravely and create a world where we want to live by joining the United Women in Faith movement. The 57-second video resonated strongly with younger audiences (ages 25–35), particularly those passionate about community support and engagement.





# **General Conference**

United Women in Faith made its presence known at General Conference 2024, which took place April 23-May 3, 2024, in Charlotte, North Carolina. United Women in Faith members and staff served as delegates,

legislative committee officers and monitors, administrative committee members, presenters, and volunteers. With the General Commission on the Status and Role of Women, United Women in Faith also brought women delegates together for briefings before the conference began.

Highlights:

- **Eighteen out of 19** of United Women in Faith's petitions passed the General Conference. These include calls to action on racial and climate justice, gender equity, protecting the girl child, and supporting deaconesses and home missioners.
- 26 deaconesses and home missioners were consecrated.
- United Women in Faith co-hosted a climate vigil, a laity dinner, a central conference women's briefing, and a briefing for all women delegates.

# United Women in Faith Makes Its Presence Known at General Conference 2024

The United Methodist General Conference met from April 23 to May 3 in Charlotte, North Carolina. For 11 days, more than 700 elected delegates from around the world reviewed more than one thousand petitions focused on how The United Methodist Church wants to be God's love in the world.

The time together also included worship, communion, prayer, meals, exhibits, missionary commissioning, deaconess and home missioner consecration, actions, vigils, and other ways United



Methodists come together as a body as part of the church's mission to make disciples of Christ for the transformation of the world.

United Women in Faith submitted 19 petitions to General Conference. These included calls to action on racial and climate justice, gender equity, protecting the girl child, and supporting deaconesses and home missioners. Eighteen of our petitions passed on the consent calendar.

Our petition seeking annual conference voting rights for retired deaconesses and home missioners missed the two-thirds majority required by less than 4 percent.

The headlines to come out of this United Methodist General Conference are different than those in years past. This year, United Methodists, by a large majority, lifted the

bans on gay clergy and same-sex wedding ceremonies and removed the antigay language from our Social Principles. They also approved regionalization, a denominational restructuring plan to help decenter the United States and bring more parity to the church's decision-making.

United Women in Faith also celebrates the support of petitions submitted by fellow agencies, racial and ethnic ministry plans, those working for creation justice, and other groups and individuals aligned on the causes of racial and climate justice and gender equity.

Our own Harriett Olson, former CEO and general secretary of United Women in Faith, was elected to the Judicial Council. Members served as legislative committee chairs, and many of our members will now also serve on general agency boards and jurisdictional committees.

"I feel like we can finally say with authenticity that we're a church of open minds, open hearts, and

open doors," said United Women in Faith member Christina Krost, longtime climate justice advocate and General Conference delegate from the Illinois Great Rivers Conference.

Krost also acknowledged the heartache of the slim loss of voting rights for retired deaconesses and home missioners.

Deaconesses and home missioners are part of an order of The United Methodist Church, one of three orders in the denomination and the only lay order.

"It is important that we have voting parity with the other two orders of our denomination," Deaconess Katelin Hansen said.

While together in Charlotte, United Women in Faith also partnered with Creation Justice Ministries, the Love Your Neighbor Coalition, and the General Boards of Church and Society and Global Ministries for an Earth Day vigil at First United Methodist Church Charlotte.

In the leadup to General Conference, United Women in Faith joined the General Commission on the Status and Role of Women to host two women's briefings, one for central conference women delegates on Saturday, April 20, and a second for all women delegates on Monday, April 22.

The briefings were a chance for the women to meet one another and share their experiences and stories.


The briefings helped set the stage for ongoing collaboration throughout the conference. The time together featured panels, testimonies, and table discussions by legislative committee so women delegates could work to support one another.

"I had a lot of hope heading to General Conference for our church's future, and I was not disappointed," said Rita Smith, a member of United Women in Faith's program advisory group and a General Conference delegate from Northern Illinois.

Women's representation at General Conference increased from 36 percent at the 2016 and 2019 General Conferences to 42 percent at the 2024 meeting of the postponed 2020 General Conference.

Gifts to the Legacy Endowment Fund build financial resources that ensure United Women in Faith can carry out our vital programs and activities for many years to come.

- The Legacy Endowment Fund has had an exceptional year, reaching an end-of-year milestone of \$46,062,552.
- Donors gave \$2,781,247 in planned and major gifts to United Women in Faith.
- The 1869 Society, made up of individuals who have made planned gifts to the organization, has grown to 136 members.

## A Planned Gift with Great Meaning

When new United Women in Faith board member Kelly G. Loeb first moved to Kansas City, Missouri, to attend school, she was blessed to find a church home at St. Andrew United Methodist Church. There she met a very special mentor, Mai Gray, the first African American national president of our organization.



The beloved Gray served from 1976 to 1980 as president of the Women's Division and was instrumental in drafting our Charter for Racial Justice. Many of us knew and admired her.

"I can remember Ms. Gray having me over to her beautiful home for lunch many times and talking with me about my future," Loeb said. "She was an amazing woman."

"Shortly after Ms. Gray's passing in 2010, I was driving past her house on Benton Boulevard and saw a 'for sale' sign," Loeb explained. "I remember thinking, 'someone nice should buy that house.' Then I heard God's voice say, you're nice; you should buy it. I was able to get a first-time homeowner's loan, and less than a week later I was signing papers. It was meant to be!"

Loeb speaks of how much it means to her to live in Rev. and Mai Gray's home and how she has kept in contact with their children, who are pleased she is caring for the home.

Loeb thought it was also in God's plan to graciously donate her special home as a planned gift to The Legacy Endowment Fund so that Mai Gray's legacy, and her own, will live on.

"I dated my letter of intent for my planned gift August 20th because that was my beloved grandmother Grace's birthday," explained Loeb. "She was born in 1922, the same year as Mai Gray, and would have been 102 this year. It feels wonderfully fitting to mark this legacy designation with that date."

# Annual Report Financials



## TREASURER'S REPORT

Mission is made possible through the financial commitments of our dedicated members. We are so grateful for the support to continue the work that United Women in Faith is called to! We need the support of members more than ever at this time.

## **Operating Revenue**

#### **Conference Giving**

Conference Giving totaled \$6.2 million, a decline of \$799,000 from the prior year. We remain thankful to all our members for their giving, especially for those conferences that increased their Mission Giving and pledge for the year! Out of 53 conferences, 21 conferences met their pledge, and seven not only met their pledge but increased their giving.

#### **Interest & Publications Income**

Interest income totaled \$2.6 million, an increase of \$305,000. Publications income totaled \$413,000, a decrease of \$71,000 due to declining subscriptions and sales.

#### Rental, Service Fee, & Other Income

Rental and Service Fee income, which includes the operations of **Brooks-Howell Home** and the **Church Center for the United Nations**, totaled \$7.5 million. There was an increase of \$892,000, which is primarily due to the Brooks-Howell Home increasing the number of health care beds available. Other Income totaled \$1.4 million, a decrease of \$388,000 compared to the prior year. The decline was due to an employer retention credit received in 2023 that was not repeated in 2024.

In total, Operating Revenues totaled \$18 million, a decrease of \$62,000 or 0.3%.



## **Operating Expenses**

#### **Programs Rendered by United Women in Faith**

The total for Programs Rendered by United Women in Faith was \$7.4 million, an intentional decrease of \$211,000, as we managed the budget to be in line with the expected Conference Giving.

The Transformation, Position, Engage, and Mobilize budgets experienced some variations due to a change in reporting, but overall, their change only nets to a difference of \$25,000. International Mission decreased due to the retirement of a Regional Missionary. National Missions decreased due to a reduction in the insurance premiums we pay.

#### **Programs Rendered by Other Organizations**

Our support to other organizations totaled \$2.5 million, a decrease of \$1.7 million due to budget reductions and awarding fewer grants from designated funds.

#### **Program Support**

Program Support, which includes expenses for the Church Center for the United Nations and Brooks-Howell Home, totaled \$8.4 million.

#### **Supporting Services**

Supporting Services, which includes management, general, and fundraising expenses, totaled \$3.7 million. This was a decrease of \$1.6 million compared to the prior year and represents 17% of the total Operating Expenses. Although this section includes what we typically think of as non-programmatic work (finance, property management, grants, human resources, fund development, etc.), the staff who perform these necessary functions often work directly with members and carry out some program activities.

Operating Expenses totaled \$21.9 million, a decrease of \$3.6 million or 14%.

## **Non-Operating Activity**

Our Non-Operating Activity includes the appreciation (or depreciation) in our investments, the change in post-retirement costs, gains on the sale of property, and contributions to our endowments, such as The Legacy Endowment Fund. The value of our investments appreciated by \$6.2 million due to the market. There was an improvement in post-retirement and pension benefit costs of \$942,000 due to investment performance and the decrease in census.

In total, Non-Operating Activity was \$8.4 million.

## Summary

Our Operating Revenue totaled \$18 million, Operating Expenses totaled \$21.9 million, and our Non-Operating Activities totaled \$8.4 million. Overall, we experienced an increase in Net Assets of \$4.6 million.



## **General Secretary**

The General Secretary's budget includes resources for the General Secretary to oversee the national office while also connecting to members at conference, district, and local events. She also participates in meetings of The United Methodist Church General Secretary's Table and the Council of Bishops. The budget includes expenses related to annual reporting, newsletters, travel, professional development, and office expenses.

#### **Board & Governance**

The 2025 Board and Governance budget supports the work and leadership development of the board of directors and program advisory group. The budget covers the cost of directors and officers insurance and travel insurance. Directors and program advisory group members attend a variety of meetings throughout the year, such as executive committee meetings, board of directors meetings, program advisory group meetings, and working teams and committee meetings. These meetings include business and team-building activities that strengthen relationships and contribute to more productive virtual meetings throughout the term. There is also a small travel reimbursement line for the program advisory group and board members who travel to other meetings as part of their position.

## **Connectional Office**

#### **Connections**

In 2025, the Connectional Office will be following up on actions from General Conference 2024, such as guiding the process for ratification of legislation approved at General Conference in 2024: 1) Regionalization and 2) Paragraph 4, Article IV, Book of Discipline, 3) Paragraph 5, Article V, Book of Discipline for United Women in Faith.

Connections will continue to develop and maintain relationships with agency partners, caucuses, and ecumenical partners; and work on equipping members of United Women in Faith to be leaders in The United Methodist Church and beyond.

The office will also guide the newly elected jurisdiction leadership teams and train the Jurisdiction Committee on Nominations.

Connections will continue to coordinate cultivation requests for national speakers at annual meetings for United Women in Faith. The Connectional Officer will continue to guide the Governance Committee work, including decisions on policy and bylaws revisions for the new quadrennium.

#### International Mission

United Women in Faith national staff members will continue working with the United Methodist Women leaders in the priority countries in Africa, Asia, and Latin America on leadership development, economic empowerment, and skills-building in the areas that they select, and assist in designing projects to address these needs and determine the implementation process. The office will continue to fund international scholarships and grants. The women's peace dialogue will continue carrying on its work.



#### **Country Teams Strategy**

National staff will continue coordinating eight country teams to:

- Train local women in their church and community
- · Conduct post-training assessments
- Prioritize identified needs

In addition to leadership, economic development, and skills-building, relevant training and team enhancements will be offered as needed.

The work uses a country team model which includes:

- National staff
- Regional Missionaries
- Project coordinators
- Women's Desk coordinators
- Youth representatives
- Local journalists
- Other local women leaders

The national staff will plan and conduct a site visit to Africa and/or Latin America to monitor the project implementation and provide technical assistance to the field staff.

#### **Educational gatherings with missionaries:**

We will continue innovating around a plan to engage our members in international work, including cross-cultural exposure and mission opportunities. Funds will also support efforts to gather information and tell the story through *Voices From the Field* and similar programs. Building on the success of the 2023 itineration, we will explore and plan further awareness-building and educational gatherings with missionaries and project coordinators around annual and district meetings to promote international mission work.

#### **Church Center for the United Nations (CCUN)**

The chaplain at CCUN will support our partnership with the World Council of Churches, special ministry, connecting with the Gender Justice Reference Group. She will continue our work with Ecumenical Women, the UN-Commission on the Status of Women, the UN-Permanent Forum on Indigenous Issues, and Thursday morning prayers at CCUN.

#### Office of Deaconess & Home Missioner (D/HM)

The Office of Deaconess and Home Missioner is an office of The United Methodist Church administered by United Women in Faith. The D/HM community has been rapidly growing in the past four to five years. In 2025, the D/HM office will engage in:

- **Deaconess and Home Missioner Education** This includes expenses such as professor and academic advisor stipends; mental health professional stipends, and scholarships for D/HM candidates and community.
- **Consecration** This includes orientation, training, and consecration service, with travel and housing.
- Other programs and administration needs Fenton Memorial Deaconess Home, selfcare retreats, financial planning, cutting-edge grants, D/HM coaching, and a nurture and care team.
- **Training** Intercultural competency and racial justice training to provide opportunities and Safe Sanctuary training and background checks for each D/HM as they enter the D/HM relationship.
- **Church and ecumenical connections** The Office of Deaconess and Home Missioner engages in multiple conferences and meetings and holds membership in professional organizations which include DOTAC, DIAKONIA, NADHM.
- **Consultants** Consultants support the work of D/HM through the discernment process, serving as liaisons, organizing interviews, and coaching. Additionally, another consultant works with the weekly newsletter.

The Office of Deaconess and Home Missioner also works with two coordinators who assist with those transferring their deaconess relationship from the Philippines and supporting the new deaconess/home missioner movement in Africa. Each of these coordinators also receives a stipend.

The Office of Deaconess and Home Missioner intentionally connects with other agencies in The United Methodist Church and tables at conferences that future deaconesses and home missioners would attend to raise our visibility and educate others on the deaconess and home missioner relationship.

#### **National Mission**

The majority of the National Mission office budget supports grants to National Mission Institutions and insurance for NMIs operating on United Women in Faith property. In addition, funds cover staff travel to NMIs, consultant fees for increasing the visibility of NMIs throughout our membership, and operational costs like rent and supplies. Staff salaries and benefits are also included, allowing the United Women in Faith National Office to support NMIs through board training sessions and consultations, member connections, and peer resourcing, as well as ensuring compliance with the Covenant Agreement.

## **Operations**

The 2025 Operations budget aims to support our staff by maintaining and optimizing systems and processes that further our strategic goals and provide a sustainable hybrid culture for our staff and members. The operations team creates print and digital resources that complement and enhance one another, designing engaging virtual events to meet the needs of our members, making the best use of the technology we have, identifying what is needed, equipping member leaders to do the same, and building a workplace that reflects the values of our members and honors their stewardship and trust in our staff.

Operations seeks to provide the structure and support that allows United Women in Faith to serve women, children, and youth worldwide while building capacity to equip the next generation of women leaders.

#### **Communications**

The Communications office continues to undergird the strategic goals and priorities of the organization. It engages with members and new audiences through affordable and effective channels such as print materials, social media, web content, e-newsletters, texts, and videos. We provide ongoing support to members and leaders with print and digital resources designed to educate, inspire, and foster leadership development.

The team also works with national office stakeholders to develop content and identify best practices for communications. The webstore is continuously being improved with cost-effective bundle options—offering print and digital resources that cater to the needs of our members and leaders. We are continuing to offer translations of our key resources. In 2025, we will be producing a publication celebrating 125 years of Mission u curricula.

We are also exploring new ways to enhance engagement, generate revenue, and create group opportunities through UWFaith Digital, an online platform designed to offer digital resources and foster community building at a sustainable cost. In 2025, we are also transferring content from Bridge to United Women in Faith Digital courses.

Additionally, we provide support to conference program resources and language coordinators in their work.

#### **Information Technology**

IT manages telecommunications services, hardware, and software supporting all aspects of work at United Women in Faith. These systems provide the tools necessary to achieve the goals outlined in our Strategic Blueprint. Since United Women in Faith has gone fully remote, IT has focused on upgrading technology and software for useability and security. Two IT additions to the 2025 budget will provide increased security and interoperability.

#### **Human Resources**

HR is dedicated to overseeing the entire employee life cycle, including recruiting, hiring, onboarding, professional development, training, employee appraisal systems, and more. HR is also responsible for planning and executing employee recognition programs, organizing staff-in events, producing the monthly employee newsletter, and conducting live meetings. We continuously seek innovative approaches to support staff in a remote work environment, striving to promote a healthy work/life balance and enhance overall employee well-being.

#### **Events Management**

Events Management is pleased to be working again with Engage, Mobilize, Development, IT, Communications, and more to further the larger strategic plan goals for the organization.

Some examples of Events Management support are below:

- Soul Care programs: resources and data collection
- Mission u: worship programming and logistics
- Leadership Development Days: worship and events management

We also provide support for all board/program advisory group meetings and virtual events such as Reading Program events, Faith Talks, and Voices From the Field.

Additionally, we support conference vice presidents as their staff liaisons.

In 2025 we will be providing significant support and creative assistance for Assembly 2026 and testing new models for sponsorship, community partners, and in-person giving.

#### **Transformation**

The 2025 Transformation Budget will continue to support the strategic work of United Women in Faith to inspire, influence, and impact our members and the lives of women, children, and youth around the world. We do this through four strategic goals under three organizational priorities: Positioning the organization, engaging and attracting new women and funding opportunities, and mobilizing women to act. The budget gives particular emphasis to these priorities as we seek to grow our membership and giving and market and promote our new brand, and continue to transform lives within and beyond The United Methodist Church.

#### **Position**

The POSITION organizational goal calls for United Women in Faith to be positioned as a leading women's Christian organization within the wider faith community and in the world. The 2025 budget continues to focus on achieving this through:

- Marketing and public relations that uplift the new brand offerings and missional programs for women to give and join.
- Expanding paid advertising and UWFaith Digital footprint through short video and ad placement on social media and online search engines. This will include Mission u, UWFaith Digital, Soul Care Retreats, social justice priorities, and leadership development opportunities.
- Working with our public information officer consultant to highlight United Women in Faith's unique personalities and production of our Faith Talks podcast.
- Welcomed Dominique Francisco, the new Position lead to drive the innovative process and expansion efforts based on the strategic goals.

#### **Engage**

The ENGAGE organizational goal seeks to attract and engage women for increased membership, funding, and donations. Engage work also encompasses being a reliable source for women's spiritual growth. The 2025 budget will support expansive opportunities for membership and spiritual growth and engagement, developing new resources and merchandise, and scaling innovative program designs:

- All-Access membership will continue to be promoted as the official way for all members to access resources, communications, and event happenings at the national level with a membership campaign soft launch in late summer/ early fall 2025.
- Spiritual growth with offerings of Soul Care programs will strategically be marketed at all levels as the newest welcoming experience.
- Mission u program is looking to grow beyond the conferences and continues to develop flexible and adaptable curricula.

- Programs like Soul Care, and resources, like Excite and Invite, and Thrive will be scaled to support districts and units for ongoing, successful recruitment, retention, and re-engagement of women.
- In 2025, distance learning will move to UWFaith Digital, as it continues to be a supportive tool for virtual events, training, and building capacity for interactive learning experiences.
- As part of the strategic blueprint, new ways to fund the work of United Women in Faith is a continual priority. A crossfunctional team has developed a funding roadmap with implementation from 2024 and will continue throughout 2025.

#### **Mobilize**

The MOBILIZE organizational goal is to mobilize members to inspire, influence, and impact their communities and the world. The 2025 budget requests continue to support this strategic work by:

- Expanding leadership and leadership development opportunities to serve as a national vehicle to strengthen and develop the leadership of United Women in Faith officers, members, and potential members through the Influence membership track.
- Continuing resource development for member leaders including conference officer welcome toolkit, district office survey, and developing templates.
- Offering educational forums on tech and social media for conference leaders to better equip members.
- Providing social action and justice campaign support including developing

- resources for social justice priorities to be scaled for the new quadrennium.
- Continuing to expand the audiences for our two advocacy campaigns—Interrupt the School-to-Prison Pipeline and Just Energy for All—to members, nonmembers, and partners.
- Building awareness of justice priorities and expanding participation, which will lead to a 15% increase in tangible action by the end of 2025.
- Supporting participation in our Reading Program, engaging an expanding group of volunteer evaluators, and offering quarterly live virtual programs including author talks and book discussions.

## Finance, Grants, & Property

Accounting handles the day-to-day work of depositing and recording receipts, disbursing and recording payments, and financial reporting. Our finance staff oversees all of our bank accounts, investment accounts, and the related internal controls to handle our financial activities. Our grants staff coordinates the review and disbursement of grants and scholarships. Our property staff oversees the national and international properties we own, lease, insure, and provide grants for. Overall, we aim to handle our responsibilities by emphasizing accountability, accuracy, and consistency as we relate to our fellow staff, our board, and the faithful members of United Women in Faith.

#### **Fund Development**

The Fund Development budget for 2025 focuses on strategies to enhance donor engagement, secure new revenue streams, and maintain relationships with key contributors. Major allocations include professional services for external consultants, grant writing, and marketing, aimed at increasing United Women in Faith's funding base.

Key line items in the 2025 budget include:

- Investments in consultants for fundraising strategies and grant writing to diversify funding.
- Costs for Day of Giving and other donor cultivation campaigns, including postage, printing, and mailing materials.
- Travel expenses for development staff to engage with donors, attend events, and lead solicitation efforts.
- Donor cultivation and recognition events designed to strengthen relationships and encourage ongoing support.
- Continuing efforts to produce high-quality promotional and informational materials to engage donors.




